REGISTRATION FEE: There is a \$20.00 annual registration fee per family which needs to be included with your returned enrollment form or forms. Your child will not be enrolled in a class until this fee is paid.

SOLO, DUETS, TRIOS & QUARTETS: Extra lessons will be given out first to senior/high school students and then on a 1st request basis. Dancers must be in first grade and have at least one year of dance experience to participate in an extra dance. Please note that requests for extra lessons are filled based on teacher and studio availability.

CLASS NOTIFICATION: I will send out your class information by email the week of August 17th. Classes will begin the week of August 24th. If you have not received your class information by August 19th please call or email the studio.

RECITAL DATES: Please note the annual studio recital will be held **May 28th and 29th, 2027.**

Buddy and Me, Ballet/Jazz/Tumbling:

Pink ballet shoes

Ballet/Jazz/Beg. Tap (1st year)*:

Pink ballet shoes, tan tap shoes

Ballet/Jazz/Tap (2nd year and up)*

Pink ballet shoes, tan jazz shoes, tan tap shoes

Ballet/Jazz/Lyrical/Tap:

Pink or White ballet shoes (age dependent), tan jazz shoes, tan tap shoes

Beg. Pointe/Jazz/Lyrical/Tap, Pointe/Jazz/Lyrical/Tap-:

Pointe shoes and gel pads, tan jazz shoes, tan tap shoes

Technique I/II/III:

No required shoes, but half soles are encouraged

PARTICIPANT AGREEMENT, RELEASE, AND ACKNOWLEDGEMENT OF RISK

In consideration of the services of Spotlight Studios LLC, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in capacity on their behalf (hereinafter collectively referred to as "studio personnel"), I hereby agree to release and discharge Spotlight Studios LLC, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that dance classes entail known and unanticipated risks which could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. **The risks include, among other things:** Collision with other participants, props, the walls or other fixed objects; falling down; my own equipment failure or the failure of other's equipment; my own or other's negligence; objects or conditions on the studio floor surface that may cause me to fall; broken bones; sprains; head, neck and back injuries; abrasions; and bruises.
2. Furthermore, Spotlight Studios LLC employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.
3. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
4. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Spotlight Studios LLC from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Spotlight Studios LLC equipment or facilities, including performance locations or any other locations where dance activity may take place, **including such Claims which allege negligent acts or omissions of Spotlight Studios LLC.**
5. Should Spotlight Studios LLC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
6. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume – and bear the costs of – all risks that may be created, directly or indirectly, by any such condition.
7. In the event that I file a lawsuit against Spotlight Studios LLC, I agree to do so solely in the state of Kansas, and I further agree that the substantive law of that state shall apply in this action without regard to the conflict of law rules of that state.
8. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect.
9. I grant permission to Spotlight Studios LLC to take and use photographs and video of students for the purposes of recital, publicity, social media, and marketing.

By signing this document, I agree that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Spotlight Studios LLC on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
